

NEW E-TRIM FILES. INSTALL REMAN LUBE PUMP, INSTALL UPDATED FLEXIBLE INTAKE HOSE ASSY FOR AIR COMP. REPLACE BOTH COOLANT HOSES TO AIR COMPRESSOR. REPLACE OIL DRAIN HOSE FOR HIGH PRESSURE TURBO. TURBOS INSPECTED DK FOR REUSE AT THIS TIME AND CUSTOMER ELECTED TO REUSE THEM, DIL SUPPLY HOSE FOR AIR COMP ALSO WAS REPLACED. FULL LOWER RAD PIPING AND INSPECT INNER CONDITION OF RAD CORE TUBES TO FIND BUILD UP AND RESTRICTIONS PRESENT. LAY A/C COND OFF TO THE SIDE, PULL C.A.C. AND REMOVE RAD FROM CHASSIS. SWAP OVER NEEDED PARTS TO NEW RAD ASSY. PRESSURE TEST C.A.C. TO FIND OK, STEAM CLEAN C.A.C. ASSY, INSTALL NEW RAD ASSY. REPLACE BROKEN LOWER LEFT SIDE HEIM JOINT FOR RAD SUPPORT SRACE.
