Removed oil filter and opened to inspect; found large amounts of metal debris inside filter. Advised Customer engine will need to be replaced. Customer approved repairs; replacement engine ordered. Once replacement engine arrived; removed failed engine from unit. Once out, swapped all necessary parts to new engine. Installed new engine into unit. Flushed out radiator due to substantial amount of dirt and debris; re-installed radiator and filled with appropriate amount of coolant. Had to replace fuel lift pump as it been converted to spin style fuel filter which we do not stock. After engine instillation was complete, started engine and let idle to operating temperature; checked for leaks and proper operation. Tested engine functions to test under load; no issues found.


